The fight for \$15 is being waged by low-wage workers across the country. In 2017, Minneapolis became the first major city in the Midwest to successfully adopt the \$15 minimum wage, which provides momentum to make this trend national and not solely a coastal phenomenon. CTUL was at the center of this battle, organizing members and supporters to win the minimum wage increase on behalf of the City's 71,000 low-wage workers whose daily lives will be meaningfully improved.

Native Rights & Environmental Justice:

Utah Dine Bikeyah | Salt Lake City, UT

Utah Dine Bikeyah (UDB) works to preserve and protect the cultural and natural resources of ancestral Native American lands to benefit and bring healing to people and the Earth. Specifically, they work to support the five local tribes (Hopi, Zuni, Ute Mtn, Uinta Ouray Ute, and Navajo) to fight for permanent protections of Bears Ears National Monument.

Bears Ears National Monument was officially designated in late 2016. To ensure that Bears Ears is protected long-term, in 2017 UDB members pushed for a strong co-management structure to ensure the voices of the five local Tribes have significant influence as National Monument planning gets underway. This victory of the Bears Ears National Monument has truly elevated the voice of Tribes in public lands discussions. Unfortunately, President Trump has moved to reduce Bears Ears National Monument protections to serve corporate interests. UDB is not standing pat. In the last few months, UDB has engaged 10,000+ community leaders through meetings, tabling at events, and marching in parades during the Utah fair season. These efforts partly resulted in UDB staff and volunteers collecting and submitting 23,000 public comments to the Department of the Interior before the public comment deadline in July 2017, regarding Trump's proposal.

Faith in Action Bay Area | San Francisco, CA

Faith in Action Bay Area (FABA) works to advance racial and economic justice in San Francisco and beyond by developing community leaders poised to advocate for long-term policy changes. By developing the leadership and collective power of low-income communities and communities of color, FABA works to address the housing crisis for low-income families, advance immigration reform, and advocate for criminal justice reform.

Leaders and members of FABA secured rent stabilization for tenants in Pacifica, a municipality located South of San Francisco in California's Bay Area. The successful ballot box Measure C campaign led by FABA brings additional security through new just cause eviction protections to approximately 2,300 rental units, representing nearly 20% of the area's housing stock. The Measure also limits the extent to which rent can be raised from one year to the next. The new policy makes a real difference to the third of Pacifica's 40,000 residents that rent.

solutions developed by local leaders. CCF's staff and advisors are able to identify community leaders who have exciting vision and organizations with promising new models and approaches.

Form 990, Part VI, Line 11b - Form 990 Review Process

Form 990 is prepared by the foundation's outside auditor after the completion of the annual audit. The draft Form 990 is reviewed by staff before being forwarded to the Board Chair and Treasurer, who review the Form 990 and make comments or corrections prior to the filing of the return. When completed, the Form 990 is distributed to the full Board of Trustees.

Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts

All Trustees of the CCF Board have read and understood the conflict of interest policy as indicated by their signature on the form. Trustees are asked to renew their commitment to the policy and to re-sign the form annually at the first meeting of the Board of Trustees each year.

The Board of Trustees reviews salary surveys from various sources, including the Council on Foundations and Exponent Philanthropy and determines the salary for the CEO based on comparable data and the CEO's experience.

The CEO follows a similar process for determining the salaries of key staff, reviewing salary surveys from a variety of sources, including the Council on Foundations and Exponent Philanthropy.
