- Collaborate with CCF's senior leadership team to support and align fundraising goals with the organization's strategic initiatives and priorities (eg. Housing justice, Native Voices Rising etc).
- Create compelling fundraising proposals, presentations, and materials to solicit funding from corporations, foundations, government agencies, and other funding sources.
- Cultivate and maintain relationships with potential and existing individual donors, including stewardship efforts to acknowledge and recognize their contributions.
- Serve as a point of contact for institutional partners, addressing inquiries, providing updates, and ensuring a positive donor experience.
- Identify, cultivate, solicit, and steward individual major and legacy gifts and encourage individual donors to consider planned and blended giving strategies.
- Collaborate with strategic philanthropic advising staff to help convert CCF clients into CCF financial supporters
- Promote optimal approaches and best practices throughout every stage of the fundraising process.
